The following is a publication of a bill which was presented by the Knesset members on behalf of the constitutional committee, law and judgment of the Knesset

Bill for the Basic Law: Jerusalem, Capital of Israel - Amendment No. 2 – Clauses regarding the area of Jerusalem and the required majority for changing them (*)

Cancellation of Article 5:	1. In the Basic Law: Jerusalem, Capital of Israel ¹ , hereby referred to as "the Basic Law", Article 5 has been canceled.
Amendment of Article 6:	2. In Article 6 of the Basic Law, in the final section/clause, the words [see the Hebrew version] "of the area of Jerusalem" will be replaced with "of the area of the Jerusalem Municipality, including the area that is described in the appendix of the proclamation expanding the borders of municipal Jerusalem beginning the 20^{th} of Sivan 5727 (June 28, 1967) ² , as was given according to the Cities' Ordinance ³ , all of which are exactly as they were on the date of introducing the Basic Law titled "Jerusalem, Capital of Israel", Amendment no. 2 – clauses on the area of Jerusalem and the required majority for changing them".
Amendment of Article 7:	3. In Article 7 of the Basic Law, the words "Clauses 5 and 6" will be replaced with "Clause 6", and the words "by a majority of the members of the Knesset" will be replaced with "by a majority of 80 Knesset members". The clauses of this article are not to be changed except through a basic law which is accepted by the majority of Knesset members".
